David Fugett called the Collective Bargaining Reopener to order at 1:30 pm.

The draft minutes for July 2, 2024, were provided to the UFF Bargaining Team and were approved.

FPU-BOT presented the following Articles:

1. Article 12 – Salaries (FPU-BOT v2, rev 7.9.24); FPU-BOT completed review of the open changes and shared update with UFF; discussion followed. Eunice emphasized that in order for the pay-period of August 16 to be effective, the agreed increase would need to be completed by the week of August 5. Faculty pay cannot be RETRO after August 9 as it conflicts with their "payment buckets". If the agreed increase is beyond August 9, payroll would need a list of new comp and manually correct what is owed in a prior pay period and have manual checks printed, or it would be paid regularly at the end of the year. Article remains open.
