3. Page 2, Section 2, line 3 a: "Florida Polytechnic University requires connectivity to Florida Industrial and Phosphate Research Institute (FIPR) located at 855 West Main Street, Bartow, Florida, 33830."

4. Page 3, Section 3, lines 1c & 2c: "Dedicated Internet Services to CCC and BARC shall not share the same physical path."

- a. Once off University property, do these two circuits need to continue to maintain physical path diversity, or may they share the same cable sheath or conduit?

Both circuits must maintain physical path diversity in which a single construction incident shall not disrupt service. Thus, both connections between CCC and BARC must not share the same conduit or cable sheath.

5. Page 9-12, Terms and Conditions:

- a. The ITB does not provide a form for objections or additional conditions to any of the terms and conditions. How would you prefer us to provide any objections or provide alternative language, if needed?






EXHIBIT I- Requested Deviation or Exemption Form
